## New Deal Mini-Project

Objective: In order to review the New Deal, students will work in pairs to present the main points of a New Deal program created by President Franklin D. Roosevelt to address the problems created by the stock market crash and the Great Depression.

Activity: Work with a partner (two people only!) to create a mini-poster (11" x 17" paper will be provided) illustrating and explaining a New Deal program.

Instructions: Use **your book** or the *GREEN* books on top of the back cabinets for this activity. Page number key: first number, regular book; second number, green book (in italics). There are charts on p. 506 and 516 (regular book) and (G 515)(G = Green book)

## Detailed instructions:

- 1. Find a partner (1 other person!)
- 2. Look over the list of New Deal programs. Choose a couple that you can work with.
- 3. Sign up for a program with the teacher (first come, first served, no doubles, be polite!)
- 4. Read more about the program you chose in either our regular book, or the green book.
- 5. Take notes on these things about your program:
  - A. General purpose of the program (ie, Relief, Recovery, or Reform)
  - B. Specific purpose of the program (ie, banking, farming, business, jobs, etc.)
  - C. Provisions of the program (ie, what did it actually do?) Get the details!
- 6. Plan a drawing that will illustrate the function of your program. Keep it simple!
- 7. When plans are done (check with teacher first), get the paper (11x17) and markers.
- 8. Make a poster that will have the ABCs from your notes (General purpose, specific purpose, provision) and the illustration. Make it **neat**, **legible**, and **clearly visible** (ie, no light sketches).
- 9. Print both partners' FIRST and LAST names, and PERIOD # neatly in regular ink at the BOTTOM of the poster. Turn it in.

Points possible: 30 (each partner) Time Frame: 1½ days (in class only!)
